Product Stewardship is an approach that acknowledges that all those involved in producing, manufacturing, selling, using and disposing of products have a shared responsibility to ensure the product does not end up in landfill.

Interloc Lockers and Partitions Pty Ltd is an Australian owned company that designs, manufactures and install lockers. As part of our commitment to environmental sustainability we have a Product Stewardship Program in place.

Interloc Lockers have made a commitment to reduce, reuse and recycle our on-site waste wherever practical through our recycling program. The next step is to assist our clients to take back our timber laminate lockers from Green Star projects to ensure the products and materials are reused & or recycled and diverted from landfill wherever possible.

The company has contractual arrangements with a number of recycling companies to include a recycler who recycles the laminate board back into particle/chip board and all metal hardware components will be recycled into the steel recycling stream.

The materials used in the lockers are:

- Particle board E0 – Vertiboard
- MDF E0 – Lamiwood & Decorwood
- Hardware components

- 2) Standard labour rates (of the day) will be applied/charged to any activity specified in Section 2 and undertaken by Interloc Lockers in order to deliver the client sanctioned product stewardship service(s).
- 3) The customer or tenant <organisation name> will be responsible for the safe removal of all power, data and communications cables/wiring prior to Interloc Lockers de-installing any products subject to product stewardship services specified in Section 2. The customer/tenant <organisation name> shall bear the costs associated with undertaking such work.

- 4) Any and all proceeds arising from any of the product stewardship services specified in Section 2 remain under the control of Interloc Lockers
- 5) Subject to agreement in writing by all parties, cost attribution other than that noted above can be negotiated between Interloc Lockers and the customer/tenant <organisation/customer name>.
- 6) The donation of product to socially oriented or community based organisation must be conditional upon acceptance of these products by these organisations prior to the implementation of this contract.
- 7) Proof of receipt must be presented for collection of timber laminated lockers
